BE IT RESOLVED, by the Council of The City of San Diego, that the authorizations contained in Ordinance No. O- 16393, introduced on March 4, 1985, and adopted on March 18, 1985, are granted with the understanding that LUSK-SMITH/MIRA MESA NORTH will, prior to sale of the multifamily mortgage revenue bonds addressed in said ordinance, enter into an appropriate agreement in a form satisfactory to the City Attorney and the City Planning Department to financially participate in the installation of ornamental lighting on Mira Mesa Boulevard, and to not oppose the establishment of an Ornamental Lighting Assessment District in said area.
