
BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$133,000.00 from Tenth Program Year Entitlement, Community Development Block Grant Fund 18520 (Barrio Parking Lot) to Community Development Block Grant Fund 185191, CIP No. 37-175 BARRIO YOUTH CENTER SWIMMING POOL FACILITY.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$441,000.00 from (\$8,000.00 from Capital Outlay Fund 30245, Non-Reimbursable Overhead, CIP No. 58-007 ANNUAL ALLOCATION - OVERHEAD AND OTHER CITY COSTS FOR FEDERAL GRANTS and \$433,000.00 from Community Development Block Grant Fund 185191, CIP No. 37-175 BARRIO YOUTH CENTER SWIMMING POOL FACILITY) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
