

RESOLUTION NUMBER R- 262775

ADOPTED ON MAR 25 1985

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Council hereby approves in concept the closure of "C" Street to motor vehicle traffic between Second and Third Avenues and between Fifth and Sixth Avenues for use by M.T.D.B., as described in Planning Department Report No. 84-626.

2. That the City Council acting under the authority of California Vehicle Code Section 21101(a) finds that these two portions of "C" Street are no longer needed for motor vehicle travel.


3. That the City Manager, City Planning Director, and City Attorney are hereby directed to proceed with the development of detailed plans for traffic flow on the altered "C" Street and to revise Ordinance No. 12626 to reflect the duties of M.T.D.B. with respect to the maintenance of the station blocks on "C" Street.

4. That the City Manager is hereby authorized to temporarily close "C" Street between Second and Sixth Avenues for the purpose of assessing the impacts of the closure on traffic circulation in the downtown area for a period of time not to exceed 90 days.

5. That it be, and it is hereby certified, that the information contained in ENVIRONMENTAL NEGATIVE DECLARATION NO. EQD 84-0342 in connection with "C" Street Widening, on file in the office of the City Clerk, has been completed in compliance

with the California Environmental Quality Act of 1970, as amended, and the State guidelines thereto, and that said Declaration has been reviewed and considered by this Council.
