

RESOLUTION NUMBER R-262781

ADOPTED ON MARCH 25, 1985

WHEREAS, Councilmember Bill Mitchell has indicated that the press of constituent business requires a significant amount of attention and time; and

WHEREAS, he has indicated in a memorandum to the Mayor, dated March 6, 1985, that he desires to relinquish his liaison appointment to the SANDAG Board of Directors; and


WHEREAS, Resolution No. R-262081, dated December 3, 1984 made such appointment pursuant to the provision of the Permanent Rules of Council; and
