APPROVING MAP OF MIRA MESA BUSINESS PARK

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Norbert Rudolph Hamelehle, a licensed land surveyor, entitled "MIRA MESA BUSINESS PARK, being a subdivision of Parcels 1 and 2 of Parcel Map 12137 recorded May 21, 1982 as File No. 82-154336 and Parcels 2 and 3 of Parcel Map 12178 recorded June 11, 1982 as File No. 82-180337, on file in the office of the County Recorder of San Diego County, in the City of San Diego, County of San Diego, State of California, including Pacific Heights Boulevard and a portion of Mira Mesa Boulevard as dedicated for public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: portions of Pacific Heights Boulevard and a portion of Mira Mesa Boulevard, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Mira Mesa Boulevard,

adjacent and contiguous to Lots 1 and 2, as shown on this map within this subdivision.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of water facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the right of ingress and egress for the construction and maintenance of water facilities, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
