BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 262795 -1, quitclaiming to LA JOLLA ALTA, a California general partnership, all the City's right, title and interest in the sewer easement, as more particularly described in the quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the quitclaim deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
