RESOLUTION NUMBER R- 262823

ADOPTED ON APR 08 1985

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the vacation of streets and public service easements by City Council resolution; and

WHEREAS, the resolution of vacation may provide that the vacation occurs only after conditions required by the legislative body have been satisfied and may instruct the City Clerk that the resolution of vacation not be recorded until the conditions have been satisfied; and

WHEREAS, Resolution Nos. R-258163 adopted March 28, 1983, relative to the vacation of Oviedo Street; and R-258279 adopted April 18, 1983, relative to the vacation of Black Mountain Road and Ossuna Canon Road, provided that the vacation occur only after the final maps for Penasquitos Bluffs East Units 1 and 2 (T.M. 82-0083) were approved by City Council action; and

WHEREAS, in the event the final subdivision maps were not approved by March 19, 1984, Resolution Nos. R-258163 and R-258279 would become void and be of no further force or effect; and

WHEREAS, the Subdivision Board has approved a time extension for the expiration of the tentative map of Penasquitos Bluffs East until May 19, 1985; and

WHEREAS, the expiration date for Resolution Nos. R-258163, R-258279, and the tentative map of Penasquitos Bluffs East should coincide; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Resolution Nos. R-258163 adopted March 28, 1983, and R-258279 adopted April 18, 1983, which are on file in the office of the City Clerk, be and the same are hereby ordered amended as follows: "That in the event the final maps are not approved by May 19, 1985, this resolution shall become void and be of no further force or effect."

2. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision maps and that the City Clerk shall then cause certified copies of said resolutions, together with this amended resolution, attested by him under seal, to be recorded in the office of the County Recorder.
