RESOLUTION NUMBER R- 262840

ADOPTED ON APR 08 1985

WHEREAS, the City Council, by Resolution No. 207396 dated February 20, 1973, authorized the City Attorney or his designated representative to incur all necessary expenses in connection with participation on behalf of The City of San Diego in those certain hearings to be held before the California Public Utilities Commission in the matter of rate increase applications by the Pacific Telephone and Telegraph Company; and

WHEREAS, the Council authorized funds to be set aside from the Unallocated Reserve for the above purpose in order to defray continuing costs incurred in such participation; and

WHEREAS, the Council by Resolutions No. 213956 dated August 6, 1975; No. 216500 dated July 28, 1976; No. 219875 dated December 14, 1977; No. 250508 dated October 29, 1979; No. 256236 dated April 19, 1982; No. 259077 dated August 15, 1983; and No. 260870 dated June 4, 1984 authorized augmentation of said Resolution No. 207396 to provide funds for continued participation in those rate hearings; and

WHEREAS, the Pacific Telephone and Telegraph Company, now Pacific Bell, has continued its efforts in rate increase applications; and

WHEREAS, said original allocation and augmentation of funds have been expended in support of participation in said hearings and it is now desired and necessary to augment again said

resolution to continue participation by San Diego in this field of concern; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller be and he is hereby authorized to transfer the amount of \$5,000 within Fund 100 from the Unallocated Reserve (605) to the Allocated Reserve (901) for the sole and exclusive purpose of providing funds to augment Resolution No. R-260870 for expenses incurred in connection with said participation in the above California Public Utilities Commission rate hearings relating to the request of Pacific Bell.
