RESOLUTION NUMBER R- 262850

ADOPTED ON APR 8 1985

WHEREAS, RAYMOND FOSTER presently leases approximately 3,600 acres of City-owned land in Pamo Valley for general agricultural uses and cattle grazing; and


WHEREAS, various studies and testing procedures, required prior to start of construction of Pamo Dam and Reservoir, have been conducted during the past few months in the southwestern portion of the leasehold; and

WHEREAS, because of the noise and general disruptions to his cattle operations caused by people and equipment conducting these tests, lessee claims the southwestern portion of the leasehold is no longer suitable for grazing; and

WHEREAS, lessee has requested and the City Manager agrees that his annual rent to City be reduced accordingly; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute a First Amendment to Lease Agreement with RAYMOND FOSTER, which amendment reduces the annual rent from \$27,000 to \$24,000, commencing March 1, 1985, under the terms and conditions set forth in that First Amendment to Lease Agreement on file in the office of the City Clerk as Document No. RR- 262850.
