RR- 262881-1 and RR- 262881-2, granting to said City easements for public street purposes in portions of the Southwest Quarter and the Northeast Quarter of Section 13, Township 14 South, Range 3 West, San Bernardino Meridian, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named SUNDANCE AVENUE and SEDORUS STREET.
