WHEREAS, the people of Korea are developing for themselves and for future generations this strikingly beautiful country of rugged mountains, meandering rivers and miles of unpolluted sandy beaches; and

WHEREAS, this development and emergence as an industrial country in East Asia coincides with an energetic exploration and renewal of a cultural heritage extending over 5,000 years; and

WHEREAS, the Asian Institute of United States International University (USIU) in cooperation with the Korean Association of San Diego is hosting an all day forum "KOREA - YESTERDAY, TODAY AND TOMORROW, An Intellectual and Aesthetic Exploration of Korea," on April 15, 1985 at USIU; and

WHEREAS, both USIU and The City of San Diego have a sisterhood relationship with Chonju University and Chonju City respectively; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby proclaim April 15, 1985 as "KOREAN CULTURE DAY."

BE IT FURTHER RESOLVED, that this Council does hereby commend the United States International University for its effort in

helping to bring the world together by creating an environment wherein people from diverse cultural, ethnic and national backgrounds can come to know each other in peace and harmony.
