Michael J. Ring	Util./Water Prod.	\$250.00	Mr. Ring was a Water Plant Operator with the Utilities Division at the time of his suggestion. He suggested adding a valve and a small amount of piping to chlorine solution. This is the remainder of his award.
George Harkleroad	GS/Buildings	\$180.00	Mr. Harkleroad is an Electrician with the Buildings Division. He suggested the City claim rebate on the SL18 light bulb. The rebate was \$600.00. This is the full award.
Patricia L. Page	Util./Waste Water Div.	\$160.00	Ms. Page is a Waste Water Plant Operator Trainee with the Utilities Division. She suggested setting up a portable toilet and phone for employees of Digester Cleaning contractors. This was considered to be an operational improvement.
Frederick W. Gabbard	Library/Sup. Serv.	\$120.00	Mr. Gabbard is an Intermediate Clerk with the Library Division. He suggested to cease renting the modem from Baker and Taylor. This is a partial award pending a 12-month review.
