CO. is hereby accepted and the City Manager is hereby authorized to execute a contract for COMPLETE TREE REMOVAL SERVICE FOR BROADLEAF TREES AND PALMS as may be required for a period of one (1) year beginning May 1, 1985 through April 30, 1986 per prices on file in the Purchasing Department; terms 5% 20 days, with an option to renew contract for four (4) additional one (1) year periods, with price escalations not to exceed 7% of unit prices for the first option year, 10% for the second option year and 15% each for the third and fourth option years.
