BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$17,000.00 from CIP No. 91-801.3 REVENUE SHARING UNALLOCATED RESERVE FUND 18013 to CIP No. 29-530 MOUNT SOLEDAD PARK - IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$67,000.00 from CIP No. 29-530 MOUNT SOLEDAD PARK - IMPROVEMENTS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
