WHEREAS, on March 25, 1985, the Rules Committee considered and discussed IRD Report No. 85-28, dated March 19, 1985, which report outlined the need for analyses of the impact on the City of federal program reductions proposed in the President's Fiscal Year 1986 Budget; and

WHEREAS, the Rules Committee unanimously approved the recommendations set forth in IRD Report No. 85-28 and now forwards the matter to the full Council with a recommendation to adopt those outlined in IRD Report No. 85-28; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, upon recommendation of the Rules Committee and after review of IRD Report No. 85-28, dated March 19, 1985, does hereby accept IRD Report No. 85-28.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to review and analyze the proposed federal budget reductions and report back to the Rules Committee by April 22, 1985, and thereafter to the Council with information on the impact the reductions would have on City programs and recommendations on alternative policy positions available to the Council.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to seek input from the Housing Authority, MTDB, RETC, the San Diego Transit Corporation and other non-City

agencies which provide services to the citizens of the City and
which may be affected by the federal budget proposals.
