RESOLUTION NUMBER R- 262918

ADOPTED ON APR 15 1985

WHEREAS, after reviewing the lottery proposition, the City Attorney believes it would be appropriate to punish as misdemeanors violations of the lottery law provisions outlawing ticket sales to persons under 18 and to anyone connected with the Lottery Commission; and

WHEREAS, the Council may wish to consider whether or not the City should sell lottery tickets as a way of raising revenue; and

WHEREAS, the Intergovernmental Relations Department, in its IRD Report No. 85-29, dated March 19, 1984, provided background, discussion, and recommendations in regard to the selling of lottery tickets; and

WHEREAS, the Rules Committee, at its March 25, 1985 meeting, reviewed and discussed Intergovernmental Relations Department Report No. 85-29 and voted to approve the recommendations contained therein; and

WHEREAS, the Rules Committee now forwards the matter to the full Council for action as recommended; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that The City of San Diego's Sacramento representative is hereby directed to seek and support appropriate legislation providing

for penalty language and provisions permitting cities to sell
lottery tickets.
