

RESOLUTION NUMBER R- 262948

ADOPTED ON APR 16 1985

WHEREAS, the City Council of The City of San Diego has committed itself to end hunger in San Diego; and

WHEREAS, Church World Service, in concert with the North County Interfaith Council and the Oceanside/Carlsbad Ministerial Association, is sponsoring a "WALK FOR THE HUNGRY" event on April 21, 1985 in three locations throughout the county, including La Jolla, Oceanside and Escondido; and

WHEREAS, proceeds from the walk will be used by Church World Service for hunger relief projects throughout the world and for designated local community agencies involved in feeding the hungry; and

WHEREAS, the local beneficiaries of the three walks being held in the region are SHARE in San Diego, Casa de Amparo in Oceanside, and the North County Crisis Center in Escondido; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and behalf of the people of The City of San Diego, does hereby proclaim April 21, 1985 as "WALK FOR THE HUNGRY DAY."

BE IT FURTHER RESOLVED, that Church World Service, the North County Interfaith Council and Oceanside/Carlsbad Ministerial Association are hereby commended for their tireless efforts to

end hunger and to reduce the suffering of millions of our fellow human beings.
