filed in the office of the City Clerk of the City of San Diego, California, on APR 22 1985 and bearing official Document No. RR-262964 be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

MAINTENANCE SURFACING VARIOUS CITY STREETS - GROUP "U" FY 85.

BE IT FURTHER RESOLVED, that the total expenditure, not to exceed \$5,854,295 (\$5,240,335 from Gas Tax Fund 30219; \$361,200 from Water Utility Operating Fund 41500; and \$252,760 from Sewer Revenue Fund 41506) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
