BE IT FURTHER RESOLVED, that the total expenditure not to exceed \$187,500 (\$82,700 from Community Development Block Grant Fund 185191, Department 5731, Organization 3104; \$30,600 from Community Development Block Grant Fund 18518, Department 5615, Organization 1501; \$60,000 from Water Revenue Fund 41502, CIP No. 73-083 ANNUAL ALLOCATION - MAIN REPLACEMENTS; \$14,200 from Capital Outlay Fund 30245, CIP No. 58-007 ANNUAL ALLOCATION - OVERHEAD AND OTHER CITY COSTS FOR FEDERAL GRANTS) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
