

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF MODIFICATION OF TRAFFIC SIGNAL SYSTEMS ON 10TH AVENUE, 11TH AVENUE AND ON MARKET STREET.

BE IT FURTHER RESOLVED, that the total expenditure, not to exceed \$129,000 from CIP No. 62-225 10TH AVENUE, 11TH AVENUE AND MARKET STREET MODIFICATIONS, (\$122,000 from Revenue Sharing Fund 18013 and \$7,000 from Capital Outlay Fund 30245) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
