BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$90,000.00 from Fund 100, Organization 200, Object Account 4222, Job Order 2718 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
