



BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a lease extension with SAN DIEGO MISSION BAY BOAT AND SKI CLUB, a copy of which lease extension is on file in the office of the City Clerk as Document No. RR- 262985, extending the term of the lease for a three-year period, or until the South Shores Master Plan for Mission Bay is implemented, with all other terms and conditions to remain in effect, except rent which will be adjusted in April 1986 in accordance with Council Policy 700-9.
