APPROVING MAP OF PENASQUITOS PARK UNIT NO. 3

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by I. Allan Cooper, a registered civil engineer, entitled "PENASQUITOS PARK UNIT NO. 3, being a subdivision of the east half of the southeast quarter of Section 13, Township 14 South, Range 3 West, San Bernardino Meridian, according to Official Plat thereof, together with a portion of Rancho Los Penasquitos, according to the Map accompanying the Patent to said Rancho, recorded in Book 2, page 385 of Patents filed in the office of County Recorder of San Diego County, all being in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Brickellia Street, Park Run Road, Creekwood Lane and Rideabout Lane, and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, all abutters' rights of access in and to Park Village Road, adjacent


and contiguous to Lot "C," as granted and shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over Lot "C," as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access and the open space easement, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
