WHEREAS, SB 1201 (Ellis) proposes through legislative intent language to give the State Lands Commission certain controls over the rental and leasing policies of the San Diego Unified Port Authority; and

WHEREAS, the Department of Intergovernmental Relations (IRD) prepared IRD Report No. 85-35, setting forth therein for the information of the Rules Committee, the present law, proposed law, discussion and issues raised by SB 1201; and

WHEREAS, the IRD Report No. 85-35 recommended that said Senate Bill be opposed; and

WHEREAS, on April 8, 1985, the Rules Committee reviewed and approved the recommendation to oppose SB 1201; and

WHEREAS, the Rules Committee now forwards the matter to the full Council for action consistent with the IRD and the Committee's recommendation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation contained in IRD Report No. 85-35 to oppose SB 1201 (Ellis) be and the same is hereby approved and adopted.
