WHEREAS, SB 1202 (Ellis) would provide for the direct election of the seven Commissioners of the San Diego Unified Port District; and

WHEREAS, as outlined in IRD Report No. 85-36, the direct election of Port Commissioners may disrupt the current balance in power between the cities which makeup the Port District and may further politicize the Port District; and


WHEREAS, the Rules Committee on April 8, 1985, reviewed and approved the recommendation in IRD Report No. 85-36 to oppose SB 1202; and
