BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the MID-CITY CHAMBER OF COMMERCE, for the purpose of distributing the \$10,000 contribution, under terms and conditions acceptable to him.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$10,000 from the General Fund 100, Unallocated Reserve (605), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
