A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE FINANCE COOPERATION AGREEMENT BETWEEN THE CITY AND THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO.

WHEREAS, The City of San Diego ( the "City") entered into United States Department of Housing and Urban Development Action Grant Agreement No. B-85-AA-06-0602(P) (the "UDAG Grant") in the amount of one million forty thousand eight hundred dollars (\$1,040,800.00) for the purpose of reconstructing the Horton Grand and Grand Saddlery Hotels (the "Project") in the Marina Redevelopment Project Area (the "Project Area"); and

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Project Area; and


WHEREAS, the City desires to use the staff, skills and facilities of the Agency to implement the above-referenced Project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the proposed Finance Cooperation Agreement between the City and the Agency, a copy of which is on file in the office of the City Clerk as Document No. RR- 263020 , is hereby approved.

BE IT FURTHER RESOLVED, the Mayor (or his designee), on behalf of the City, is hereby authorized to execute the above-referenced Finance Cooperation Agreement.

BE IT FURTHER RESOLVED, the City Manager (or his designee) is hereby authorized, on behalf of the City, to sign all documents necessary and appropriate to carry out and implement the terms of the Finance Cooperation Agreement, and to administer the City's obligations, responsibilities and duties under the Finance Cooperation Agreement.
