Julie Reed	Utilities/Metro	\$ 80.00	Ms. Reed is a Intermediate Typist with the Utilities Division. She suggested the removal of a protruding pipe from the ground to avoid injury. This was considered to be a significant safety improvement.
James D. Meyer	Park & Recreation	\$ 70.00	Mr. Meyer is a Lifeguard with the Park & Recreation Division. He suggested the reinforcement of the cavitation plates on outboard engines. This is the full award based on actual time and material savings of \$228.
Renee J. Steele	Personnel	\$ 45.00	Ms. Steele is a Intermediate Clerk with the Personnel Division. She suggested the use of standard #2 pencils instead of the mechanical ones. This is the full award based on estimated material savings of \$145.
Yvonne M. Francel	Utilities/Metro	\$ 45.00	Ms. Francel is a Grounds Maintenance Worker with the Utilities Division. She suggested the replacement of a 3/4 ton Dodge pick-up with a Ford Courier and small trailer. This was consider to be a significant safety improvement.
