

That the City Manager be and he is hereby authorized and empowered to pay the sum of \$45,000.00 in the settlement of Superior Court Case No. 516589, Marilyn Jaworski, etc. v. The City of San Diego, et al., and each and every claim against The City of San Diego, its agents and employees, resulting from the personal injury to Marilyn Jaworski on or about July 27, 1983.

That the City Auditor and Comptroller be and he is hereby authorized to issue a warrant check in the amount of \$45,000.00 made payable to Marilyn Jaworski, by her legal guardian, Estella Jaworski, and David D. Ribeiro, her attorney of record, in full settlement of the lawsuit and of all claims.
