2. That the City Auditor and Comptroller be and he is hereby authorized to issue a warrant check in the amount of \$45,000.00 made payable to Jacquelyn McDonald and her attorneys, the law firm of Thorsnes, Bartolotta, McGuire and Padilla, in full settlement of all claims.
