BE IT FURTHER RESOLVED, the the expenditure of an amount not to exceed \$46,161.80 from the project contingency for CIP 52-103.1, Capital Outlay Fund 30245, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
