
BE IT RESOLVED, by the Council of The City of San Diego, that this City Council does hereby adopt the Mission Trails Regional Park Master Development Plan, to serve as a guide for the preservation and restoration of Mission Trails Regional Park and to set forth recommendations for its future use and development, under the terms and conditions set forth in the Master Development Plan on file in the office of the City Clerk as Document No. RR- 263065 - 1.

BE IT FURTHER RESOLVED, that this City Council does hereby adopt the amendments to the Tierrasanta Community Plan, the East Elliott Community Plan boundary and the amendment to the General Plan Map entitled "Progress Guide and General Plan for The City of San Diego," copies of which are on file in the office of the City Clerk as Document Nos. RR- 263065 - 2, RR- 263065 - 3 and RR- 263065 - 4.

BE IT FURTHER RESOLVED, that this City Council does hereby stipulate that the Mission Trails Regional Park Master Plan, amendments to the Tierrasanta Community Plan, East Elliott Community Plan and General Plan Map, shall become effective upon adoption of an appropriate amendment to the Progress Guide and General Plan for the City of San Diego, incorporating said plans,

an omnibus hearing on these and other amendments to be scheduled for the next semi-annual hearing conducted for this purpose.
