
ADOPTED ON MAY 6 1985

BE IT RESOLVED, by the Council of The City of San Diego, that the bid of MCKESSON ENVIRONMENTAL SERVICES is hereby accepted and the City Manager is hereby authorized and empowered to execute a contract with MCKESSON ENVIRONMENTAL SERVICES for furnishing LABORATORY SERVICES FOR ORGANIC PRIORITY POLLUTANT ANALYSES on samples from the Tijuana Intercept as may be required for a period of one year beginning July 1, 1985 through June 30, 1986 per prices on file in the Purchasing Department, for a total estimated cost of \$38,400.00; terms net 30 days.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to take all actions as may be appropriate and necessary to request reimbursement for The City of San Diego from the United States Government for the testing of the Tijuana Intercept Sewer.
