BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of SOUTHLAND ENVELOPE COMPANY, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of 700,000 ENVELOPES (window) at a cost of \$9.85 per thousand, for a total cost of \$6,895.00; and 700,000 ENVELOPES (return) at a cost of \$8.91 per thousand, for a total cost of \$6,237.00; for a combined total cost of \$13,132.00; terms 1% 15 days, plus sales tax.


