BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF ALVARADO PIPELINE NO. 2, PHASE II.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$2,517,140 from Water Revenue Fund 41502, CIP No. 73-166.1 ALVARADO PIPELINE NO. 2 - PHASE II is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
