BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

THE CONSTRUCTION OF WATER MAIN REPLACEMENT GROUP 445.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute for and on behalf of the City of San Diego Pipeline License No. 11003307-25 with the Atchison, Topeka and Santa Fe Railway Company for the construction and maintenance of Water Main Replacement Group 445 within the Railway right-of-way.

BE IT FURTHER RESOLVED, that the expenditure not to exceed \$250 from Water Revenue Fund 41502, CIP No. 73-083 ANNUAL ALLOCATIONS - MAIN REPLACEMENTS is hereby authorized solely and exclusively for license fees payable to the Atchison, Topeka and Santa Fe Railway Company.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,147,000 from Water Revenue Fund 41502, CIP No. 73-083 ANNUAL ALLOCATION - MAIN REPLACEMENTS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
