BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those street easement deeds of PARDEE CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing dates of December 26, 1984 and March 21, 1985, copies of which deeds are on file in the Office of the City Clerk as Document Nos.

RR- 263089 -1 and RR- 263089-2, granting to said City easements for public street purposes in portions of Lots 3 and 6 of Casa New Salem Unit No. 2, Map No. 9130, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named WESTONHILL DRIVE and WESTMORE ROAD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
