APPROVING MAP OF LA JOLLA CENTRE


BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Michael L. Rust, a registered civil engineer, entitled "LA JOLLA CENTRE, being a subdivision of a portion of Parcel 2 of Parcel Map No. 11423, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County, June 26, 1981 as File No. 81-201243 of Official Records, together with portions of La Jolla Village Drive and Towne Centre Drive as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: a portion of La Jolla Village Drive and a portion of Judicial Drive, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to La Jolla Village Drive, adjacent and contiguous to portions of Lot 1, as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated, and that those certain abutters' rights of access, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
