

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$71,352 of unencumbered funds remaining in the completed Ocean Boulevard Improvements Phase 1 (CIP 23-823) to Ocean Boulevard Improvements, Phases 2 and 3 (CIP 23-8231).

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to negotiate an amendment to the contract with Van Dyke and Associates, Inc., for providing additional work for Phases 2 and 3.
