

RESOLUTION NUMBER R- 263117

ADOPTED ON MAY 6 1985

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the portion of street or highway to be vacated is excess right-of-way and is not required for street or highway purposes; and

WHEREAS, Centre City Development Corporation has requested the vacation of the southerly half of Island Avenue, adjacent to Lots A and L of Block 115 of Horton's Addition, Book 13, Page 522 of Deeds, to facilitate development; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the southerly half of Island Avenue, adjacent to Lots A and L of Block 115 of Horton's Addition, Book 13, Page 522 of Deeds, as more particularly shown on Drawing No. 16366-B on file in the office of the City Clerk as Document No. RR-263117-/

which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

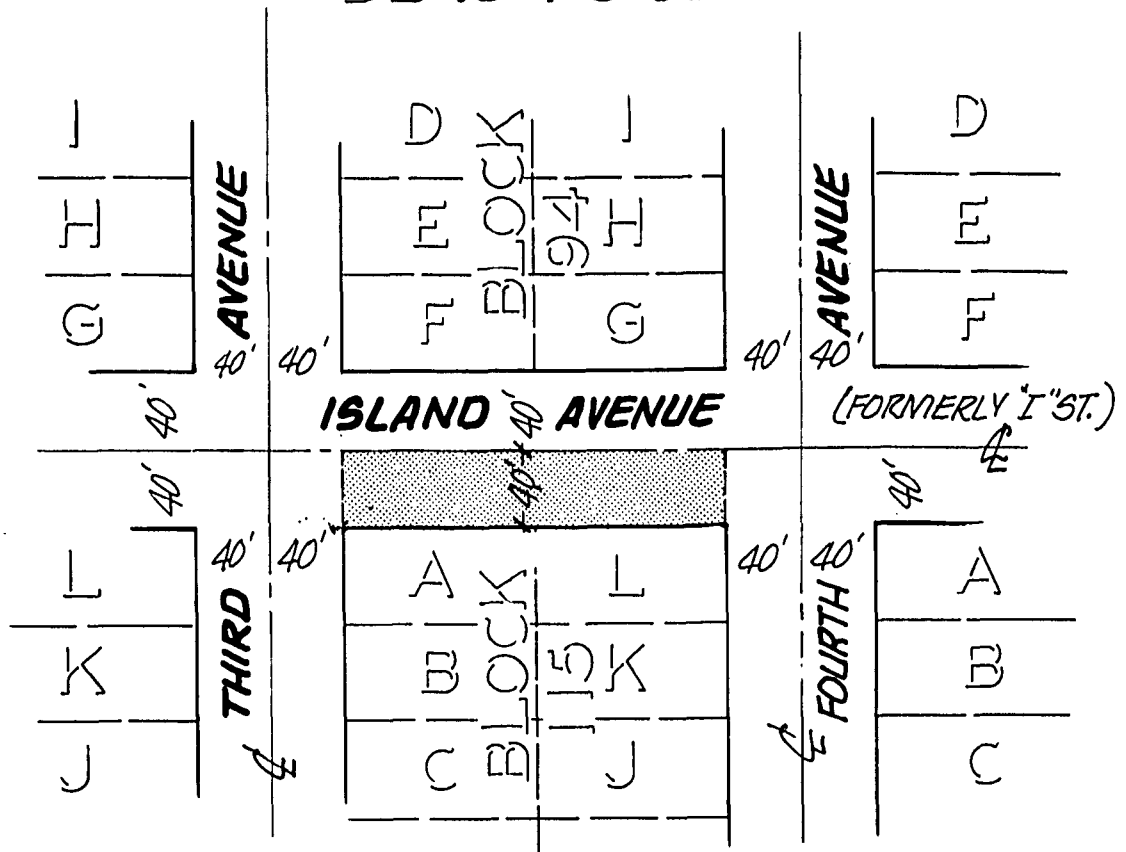
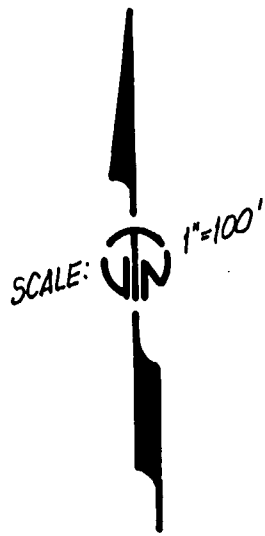

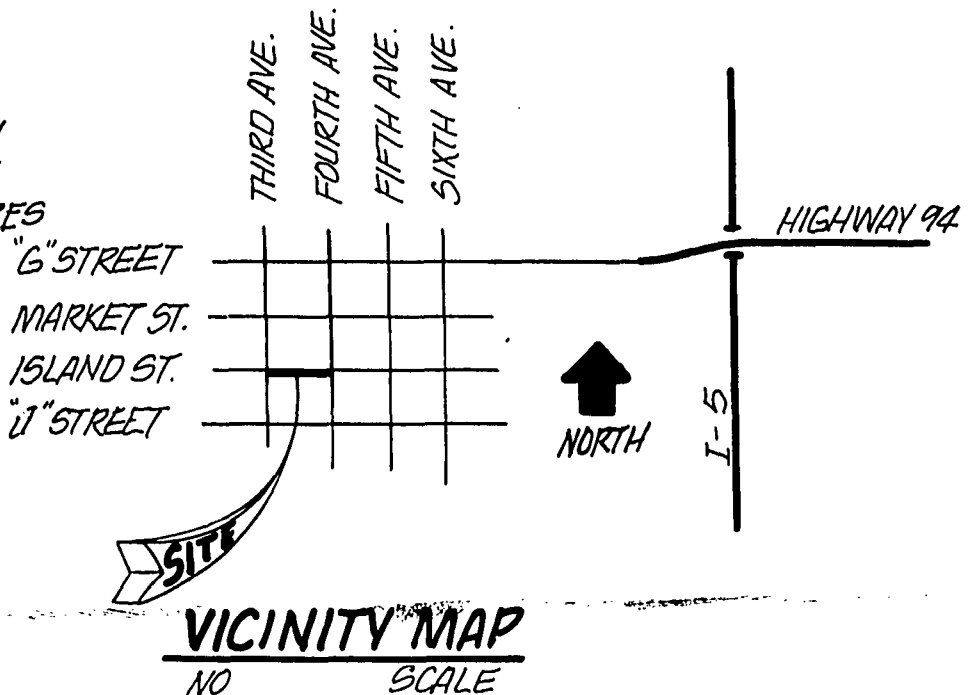
