


RESOLUTION No. R-263136 (R-85-1999)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the offer of UNIVERSITY MICROFILM INTERNATIONAL is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing RETROSPECTIVE SERIALS ON MICROFILM for a cost of \$11,001.30 and a handling and shipping charge of \$220.00, for a total cost of \$11,221.30; terms net 30 days, plus applicable sales tax.
2. That a contingency cost is hereby provided not to exceed \$1,000.00 to provide for any rate increase at time of shipping.
