APPROVING MAP OF MEADOWBROOK VILLAGE

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Gary L. Hay, a registered civil engineer, entitled "MEADOWBROOK VILLAGE, being a subdivision of a portion of Lot 12 of the Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made in an action entitled "Commercial Bank of San Diego vs. Juan M. Luco, et al" on file in the office of the County Clerk of San Diego County, together with that portion of Jamacha Road dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: a portion of Jamacha Road and a portion of Meadowbrook Drive, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the building restricted easement over a portion of Lot 1, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated, and that the building restricted easement, as granted and shown on this map within this subdivision, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
