## LEGAL DESCRIPTION

The Westerly 10 feet of the following described parcel:

All that portion of the Southwesterly Quarter of Lot 124 of the Pueblo Lands of San Diego in the City of San Diego, County of San Diego, State of California, according to map thereof made by C. H. Poole in 1856, a copy of which said map was filed in the Office of County Recorder of San Diego County, November 14, 1921, and is known as Miscellaneous Map No. 35, described as follows:

Beginning at a point on the Westerly line of said Southwesterly Quarter, distant thereon 50.00 feet Southerly from the Northwesterly corner thereof; thence Easterly parallel with the Northerly line of said Southwesterly Quarter 100.00 feet; thence Southerly parallel with the Westerly line thereof, 50.00 feet; thence Westerly parallel with said Northerly line 100.00 feet to a point on said Westerly line; thence Northerly along said Westerly line 50.00 feet to the Point of Beginning, said Southwesterly Quarter of said Pueblo Lot 124 being sometimes known as Lot 1 of Block 124 of La Playa, and also as Lot 1 of Block 20 of beach lots of San Diego, according to map thereof made by Lieutenant Cave J. Coutts in 1849.
