BE IT RESOLVED, by the Council of The City of San Diego, that this City Council, for and on behalf of the people of San Diego, hereby expresses its admiration, gratitude and appreciation to the residents of the Kensington community for their civic achievement and wishes their community a happy anniversary and best wishes for the next seventy-five years, and does proclaim May 27, 1985 as "Kensington Day" in The City of San Diego.
