
ADOPTED ON MAY 13 1985

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$2,000 from Park Service District Fund 15582 to CIP No. 29-450.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$22,000 from CIP No. 29-450, Presidio Community Park Improvements, Park Service District Funds, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
