WHEREAS, the City Manager was authorized by Resolution No. R-261345 of August 13, 1984 to enter into a contract with the lowest responsible bidder for the painting of the First Avenue Bridge at a sum not to exceed \$250,000.00; and

WHEREAS, the City Manager executed a contract with Freeman General, Inc., for this project for the sum of \$178,418.00; and

WHEREAS, as the blast cleaning and painting work progressed, it became apparent that the area between the top steel members of the bridge and the concrete bridge deck slabs had movement which allowed moisture penetration and corrosion of the top steel section, which condition was not evident prior to the award of contract and the cleaning of the steel in preparation for the painting; and

WHEREAS, additional caulk painting and work in connection therewith will be required in order to properly form an airtight seal to correct this condition in accordance with requirements approved by the California Department of Transportation; and

WHEREAS, this additional work will require the issuance of a change order to contract Document No. RR-261345 in the amount of \$31,505.33; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to execute for and on behalf of said City, change order number 1 to contract Document No. RR-261345, a copy of which is on file in the office of the City Clerk as Document No. RR-263160.

BE IT FURTHER RESOLVED, that the expenditure of \$31,505.33 is hereby authorized from Fund #3220, Account #4213, Job Order #32224, solely and exclusively for this purpose.
