

RESOLUTION NUMBER R-263161

ADOPTED ON MAY 13, 1985

WHEREAS, SB 61 (Deddeh), as amended February 14, 1985, would permit certain governmental structure proposals impacting The City of San Diego to proceed notwithstanding the fact that the San Diego Local Agency Formation Commission (LAFCO) has not adopted spheres of influence for the City or other affected agencies as required by law; and

WHEREAS, the Intergovernmental Relations Department (IRD) provided to the Rules Committee a complete analysis, discussion and recommendation to oppose the measure in IRD Report No. 85-33; and

WHEREAS, on April 8, and April 22, 1985, the Rules Committee reviewed IRD Reports No. 85-33 and 85-42 on SB 61 and took action to recommend that the City Council oppose SB 61 unless it is amended so that it does not apply to any territory or proposals of concern to The City of San Diego; and


WHEREAS, the Rules Committee now forwards the matter to the full Council for action consistent with the recommendation of IRD as amended by the Rules Committee; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that after reviewing the recommendation contained in IRD Reports No. 85-33 and 85-42, as amended by the Rules Committee, in respect to SB 61 (Deddeh) and/or any other similar legislation, this Council hereby declares its support for legislation permitting LAFCO to

act on such proposals as specified in the bill provided that (1) the application for the proposal was filed with LAFCO by December 31, 1984; and (2) that LAFCO finds that there is a reasonable probability that the proposal will be consistent with the sphere of influence being prepared for the local agency for which the proposal is proposed.
