WHEREAS, every two years the Council adopts legislative guidelines providing general direction to the Intergovernmental Relations Department; and

WHEREAS, on April 22, 1985, the Rules Committee reviewed IRD Report No. 85-32 on proposed 1985-86 legislative policy guidelines; and


WHEREAS, the Rules Committee recommended adoption of the proposed 1985-86 legislative policy guidelines as contained in IRD Report No. 85-32 and as modified by Rules Committee members to include guidelines in support of neighborhood dispute resolution centers, added penalties for adults furnishing drugs to children, and full cost reimbursement to the City for services or facilities provided to other governmental entities; and
