BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100, the sum of \$130,000 from the Unallocated Reserve (605) to the Police Department (110) for the sole and exclusive purpose of providing funds for security in Balboa Park.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to solicit bids for private security service in Balboa Park.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby fully authorized to execute an agreement, after said solicitation of bids, with a private security company for Balboa Park security.

BE IT FURTHER RESOLVED, that the expenditure of the sum of \$130,000 from the Police Department budget for the purpose of providing private security in Balboa Park be and the same is hereby authorized.
