RESOLUTION NUMBER R- 263175

ADOPTED ON MAY 14 1985

WHEREAS, the State of California proposes to improve an eight block segment of Highway 15 through a portion of the City of San Diego along the 40th Street corridor; and

WHEREAS, significant adverse impacts to the Mid-City community could result unless they are properly mitigated; and

WHEREAS, all parties agree that a primary goal in the development of this freeway is to cover the eight blocks between Adams Avenue and Landis Street, subject to the availability of funding; and

WHEREAS, the State has committed itself to provide for the cover of one block and the City has committed to provide for the cover of one additional block; and

WHEREAS, additional funds will be needed to cover the remaining blocks; and

WHEREAS, members of San Diego's state legislative delegation whose districts include this segment of State Route 15 have signed a letter which states that they "look forward to working closely" with the City "to develop a plan to fund additional blocks of cover;" NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that San Diego's state legislative delegation is requested to confer with the California Transportation Commission and with the State Department of Transportation in order to determine what funds are available for such a project.

BE IT FURTHER RESOLVED, that the City's state legislative delegation is further requested to take all appropriate steps to secure such funds for the 40th Street cover project.

BE IT FURTHER RESOLVED, that the City's federal legislative delegation is requested to take all appropriate steps to secure federal 4R funds for the project.

BE IT FURTHER RESOLVED, that the City Manager is directed to report back to the Transportation and Land Use Committee on various alternatives to finance additional cover over the freeway, including but not limited to the feasibility of establishing a site specific enterprise zone and other redevelopment financing methods as a means of generating revenue for the cover project.
